George Kachulis Inducted into American College of Trial Lawyers

There are currently approximately 5,800 members in the United States, Canada, and Puerto Rico, including active Fellows, Emeritus Fellows, Judicial Fellows (those who ascended to the bench after their induction), and Honorary Fellows. The College maintains and seeks to improve the standards of trial practice, professionalism, ethics, and the administration of justice through education and public statements on independence of the judiciary, trial by jury, respect for the rule of law, access to justice, and fair and just representation of all parties to legal proceedings. The College is thus able to speak with a balanced voice on important issues affecting the legal profession and the administration of justice.

Mr. Kachulis is a partner at Dickie McCamey and serves on the firm's Executive Committee.
