## Samuel Grego Honored with Pennsylvania Legal Aid Network Excellence Award

PLAN solicited nominations from across the Commonwealth and based its selection on a variety of criteria that demonstrated excellence and diligence in helping improve the availability and quality of civil legal services for low income people and victims of domestic violence in Pennsylvania.
