## Two Dickie McCamey Attorneys Named Among the Who's Who in Energy

According to the *Pittsburgh Business Times*, the honorees in its supplement, including professionals in accounting, finance, law, oil and gas, utilities, midstream, and education, earned recognition as "movers and shakers in the ever-changing, fast-paced energy industry" in western Pennsylvania.
